After retirement of the copper facilities, CBT will

- (1) no longer offer services over the copper facilities; and
- (2) cease maintaining copper facilities.

All services previously provisioned over copper facilities to affected customers will continue over fiber facilities.

There are approximately 19 CBT customers in the addresses affected by this copper retirement. CBT is actively working to move these customers to fiber facilities.

The known providers of telephone exchange service providers that interconnect directly with CBT at these addresses have been notified.
