Network Change Summary:

The Cincinnati Bell Telephone d/b/a altafiber Network Solution's (CBT) the Glencoe Kentucky switch located at 108 Ross, Glencoe, Kentucky.

Customers previously served by these switches were migrated to a CBT MetaSwitch (EVDLOHEVPS2) located in Evendale, Ohio. There are no remaining customers within these switches or interconnected carriers. Therefore, CBT is filing under the 51.333 (b)(2) rule.

Description of type of changes planned:

The Cincinnati Bell Telephone d/b/a altafiber Network Solutions (CBT) ORM switches listed in the chart below will be retired and removed from the CBT network. All customers served by this switch were migrated to a CBT MetaSwitch (EVDLOHEVPS2) located at 10000 Reading Rd, Evendale, Ohio 45241.

Description of Reasonably Foreseeable Impact of the Planned Changes:

There are no interconnected carriers in these ORM switches. All carriers, including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs), ILECs, wireless carriers, and paging carriers wanting to connect in these areas, will need to provision new direct end office trunk groups to support traffic routing to the Evendale, Ohio MetaSwitch (EVDLOHEVPS2). Future ASRs should reflect CLLI EVDLOHEVPS7 for T1 & T3 facilities and reflect EVDLOHEVPS2 for trunking/DS0s.

Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the switches (on or before 12/20/2025). (This will serve to guide the re-homing of traffic for the NPA-NXXs currently served by the switches to the Evendale, Ohio MetaSwitch.)
