Network Change Summary:

The copper facilities serving specific addresses in the Covington, Kentucky wire center, are being retired due to a failing culvert due to flooding in the area. The addresses included in this filing are in the communities of Southgate and Wilder, Kentucky. All addresses are served from the Covington, Kentucky wire center. Filing is 51.333(g)(2) due to the City of Wilder's urgent need to repair or replace the 120" metal culvert at Bentwood Hills Drive in Wilder, KY.

Description of type of changes planned:

Cincinnati Bell Telephone LLC d/b/a altafiber Network Solutions (CBT) has engaged in a project to upgrade the network and therefore will retire the copper facilities at these locations and replace them with fiber-to-the-premises. The addresses included in this filing are in the communities of Southgate and Wilder, Kentucky. All addresses are served from the Covington, Kentucky wire center.

- (1) no longer offer services over the copper facilities; and
- (2) cease maintaining copper facilities.

All services previously provisioned over copper facilities to affected customers will continue over fiber facilities.

There are approximately 7 CBT customers in the addresses affected by this copper retirement. CBT is actively working to move these customers to fiber facilities.

There are no known providers of telephone exchange service that interconnect directly with CBT at these addresses.
