Network Change Summary:

The copper facilities serving specific addresses in the Warsaw, Kentucky wire center, are being retired due to projects to upgrade facilities in the area. The addresses included in this filing are in the communities of Gallatin County and Sparta, Kentucky. All addresses are served by the Warsaw, Kentucky wire center.

Description of type of changes planned:

Cincinnati Bell Telephone LLC d/b/a altafiber Network Solutions (CBT) has upgraded the copper facilities at these locations within the Warsaw, Kentucky wire center and replaced them with fiber-to-the-premises. There are no active customers or services within the addresses within this public notice; therefore, filing under 47 CFR 51.333(b)(2).

Description of Reasonably Foreseeable Impact of the Planned Changes:

After retirement of the copper facilities, CBT will

- (1) no longer offer services over the copper facilities; and
- (2) cease maintaining copper facilities.

All services previously provisioned on copper facilities have already been converted to fiber facilities.

There are no customers within the addresses affected by this copper retirement.

There are no known providers of telephone exchange service providers that interconnect directly with CBT within these addresses.
